



## **NOTICE OF PUBLIC HEARING**

### **DELAWARE COMPENSATION RATING BUREAU PROPOSED RATE INCREASE FILING**

INSURANCE COMMISSIONER KAREN WELDIN STEWART, CIR-ML, hereby gives notice that a PUBLIC HEARING will be held on Monday, February 10, 2014 and Tuesday, February 11, 2014, beginning at 9:30 a.m., in the auditorium on the Mezzanine of the Carvel State Office Building, 820 North French Street, Wilmington, DE 19801. Although the Hearing has been scheduled to be held over the course of two days, the first day (February 10, 2014) will be reserved for the receipt of oral comments from members of the public, and the second day (February 11, 2014) will be reserved for the introduction of evidence by the parties to the proceeding. If all parties agree, introduction of evidence by the parties may begin on the first day.

The purpose of the hearing is to consider whether the Delaware Compensation Rating Bureau (DCRB) Workers Compensation Bureau Filing No. 1305, dated October 9, 2013, complies with applicable law and should be allowed to go into effect, or whether the filing should be disapproved. The filing requests an overall rate level change of +38.52% for the residual market rates and requests an overall loss cost level change of +41.75% for the voluntary market loss costs. These filed amounts were based on indicated changes of +38.52% for the residual market rates and +41.75% for the voluntary market loss costs. The hearing will be conducted pursuant to applicable law, including without limitation 18 Del. C. §§ 2605 and 2610, 29 Del. C. §§ 10121-29, and Delaware Insurance Department Regulation 804. The docket number assigned to this hearing is 2275-2013. The Honorable Joshua W. Martin, III, has been appointed to serve as the Hearing Officer.
